5. To strengthen the ability to write and publish quality research papers.

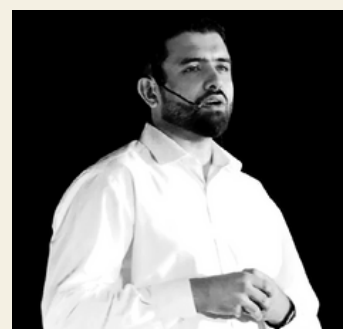
