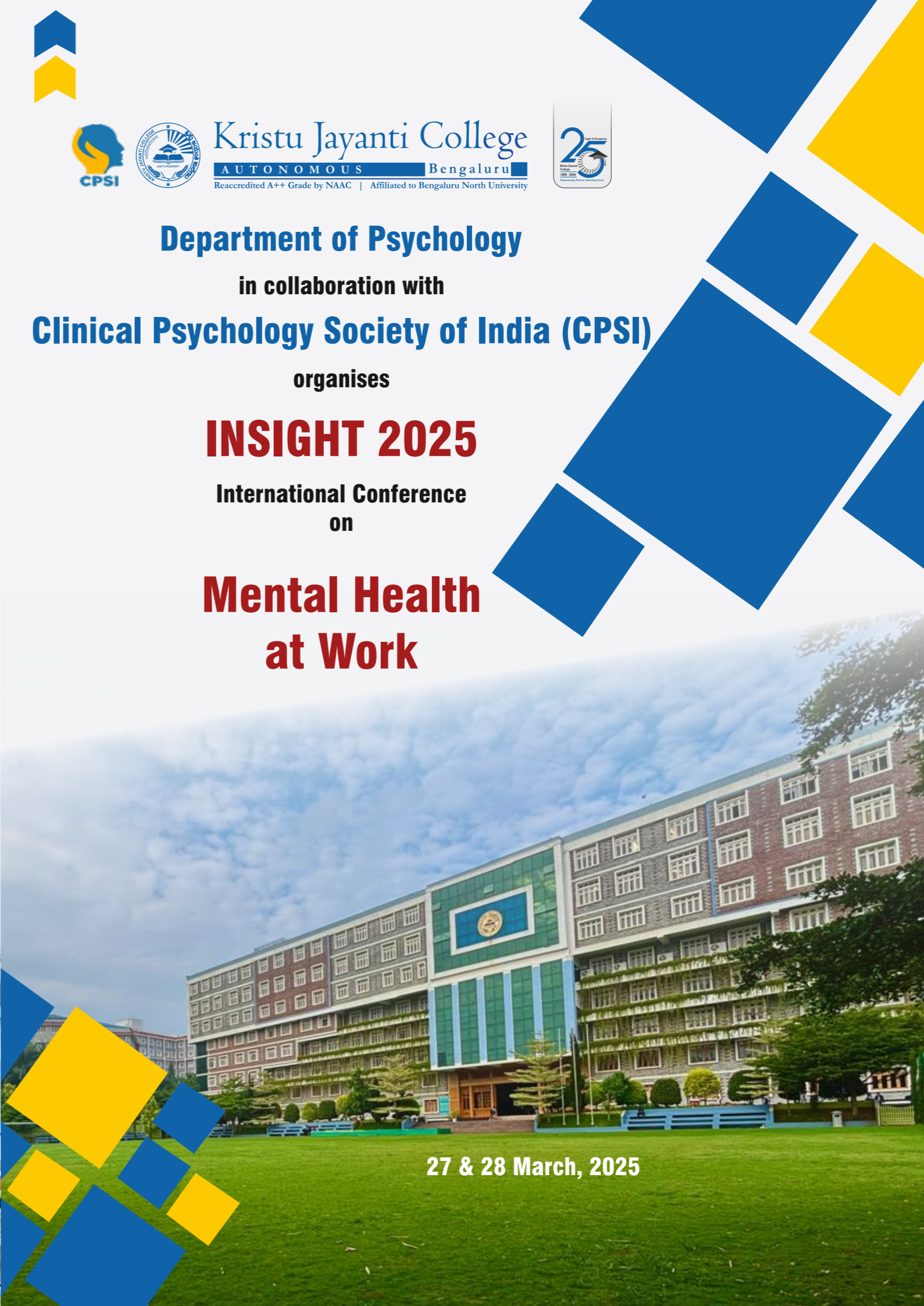

- **Participation/Presentation of the paper should be confirmed** on or before **22nd March 2025**, by sending the completed registration form, and the registration fee.

- Selected papers presented in the conference may be considered for publication in a journal (Scopus indexed) and proceeding after due review process.
