PUBLICATION

PAPER SUBMISSION GUIDELINES

- ▶ The papers should be based on original research work, not yet published and not exceeding 2500 words or 7 pages.
- ▶ If the paper has been sent for publication elsewhere, the fact must be disclosed.
- ▶ The paper should include the title, author's name, mailing address, telephone number and e-mail address. The full paper should be mailed to icrpp@kristujayanti.com on or before 1st February 2025.
- ▶ Research papers submitted after 1st February, 2025 will not be accepted. Presentation of paper should be confirmed on or before 4th February 2025 by submitting the completed Registration Form (Google form), along with payment of registration fee
- ▶ Registration form, along with the registration fee should be submitted on or before 15th February 2025.
- ▶ Soft copy of the article should be submitted in A4 size MS-Word format only with Times New Roman font, heading in font size 14 and remaining text size 12 with the line spacing of 1.5.
- ▶ Plagiarism should not exceed 20%.
- ▶ Ensure that Artificial Intelligence-generated content does not exceed 5%.
