About The Conference

Climate affects nearly every aspect of our lives, from our food sources to our transport infrastructure, from what clothes we wear, to where we go on holiday. It has a huge effect on our livelihoods, our health, and our future. Though we often think of human-induced climate change as futuristic changes, it is an ongoing process. Ecosystems and communities around the world are being impacted today because of changes in the climate. Global temperatures rose about 1.98°F (1.1°C) from 1901 to 2020, but climate change refers to more than an increase in temperature. It also includes sea level rise, changes in weather patterns like drought and flooding, and much more. Things that we depend upon and value — water, energy, transportation, wildlife, agriculture, ecosystems, and human health — are experiencing the effects of changing climate. Global Climate Change is the fieriest topic at present in the contemporary scenario. To understand this importance of conservation and prevent further drastic impacts of the wide-spreading global climate change, it is imperative to devise a curriculum for students and other stakeholders to combat the posed threat.

The 27th United Nations Climate Change Conference, COP27, comes at the tail end of a record-smashing summer for the northern hemisphere. Punishing early spring heat waves in South Asia killed hundreds. Many countries recorded the highest temperatures since records began, more than 120 years ago. Europeans experienced their hottest summer in 500 years, accompanied by wildfires, droughts, and death. Major rivers reached record low levels. The last seven years have been the hottest ever recorded. And they're just a taste of what to expect if we continue to fail to act on global heating. There is no time to lose. We are rapidly approaching dangerous tipping points for every aspect of human life, from our health and safety, our natural environment, and our economies, to our property and infrastructure. United Nations Secretary-General António Guterres has said climate action must be our "top global priority".

Decision-makers must stand in solidarity with the most vulnerable populations and put the world on track for a more prosperous future. Educating future generations about the causes and effects of global climate change is imperative since implementing solutions depends on an informed public, for both societal and individual-level actions. To respond to the changing climate and prevent the adverse effects of it is very much vital as it is directly linked with sustainable development goal "Climate Action" and also with others sustainable development goals such as "Good Health and Well-being", "Life below Water" and "Life on Land"

- Full papers with a minimum word limit of 2,500 and the maximum word limit of 4,000 words.
