Human trafficking is a grave violation of human rights, involving the exploitation of people through force, fraud, or coercion for purposes such as forced labor, sexual exploitation, and slavery. It affects millions globally, targeting vulnerable individuals, and is driven by profit, making it a significant global issue.

In 2024, significant strides were made in combating human trafficking globally, as highlighted in the U.S. Department of State's Trafficking in Persons (TIP) Report. One key achievement was the increased identification of trafficking victims, rising from 115,324 in 2022 to 133,943 in 2023. Convictions also saw a notable increase, reflecting a more robust global response to this grave issue.

Heroes in this battle include individuals like Al-Amin Noyon, a survivor and advocate from Bangladesh, who has been instrumental in supporting other survivors through the BRAC Migration Welfare Centre. Another is Marcela Martinez, a Bolivian lawyer whose initiatives

have helped locate over 150 trafficking victims. These heroes exemplify the relentless global commitment to eradicating human trafficking.

While challenges remain, such as the gap between identified victims and convictions, these advancements underscore the importance of continued international collaboration and survivor-led advocacy in combating human trafficking.

To conclude, enhanced international cooperation, increased survivor support services, and a focus on prevention would address the root causes of trafficking, such as poverty and inequality, will be vital in reducing the prevalence of this crime globally. Continued efforts to involve survivors in policy-making and advocacy are also essential for informed and effective strategies.
